The certification was approved in December 2016 by DNV GL, one of the leading, global providers of accredited management systems certifications, following the law firm's implementation of an Information Security Management System. This system allows the firm to adopt a structured and highly disciplined approach to the management of the security of assets entrusted to it by clients, as well as to detect and prevent security breaches.
