Law Firm of the Year in Transportation: “the team has advised on two key operations in Italian transport: the industrial relaunch of Alitalia under extraordinary administration and the entry of Ferrovie dello Stato Italiane in Milan’s local transportation system through the acquisition of a stake in Metro 5”.

The work of all the nominated firms were evaluated by a technical jury composed of top managers of leading companies and banks – which was divided by work groups per winning categories.
